Student's Grievance Redressal Committee Report 2021-2022


According to the directives of MUHS, Nashik, the Student's Grievance Redressal Committee meets once every two months or as needed.


During the academic year 2021-22, the Student Grievance Redressal Committee held six meetings:

1. The first meeting was held on 26/07/2021, to review the redressal of student grievances in 2020-21, as well as concerns raised by interns and undergraduate students about basic necessities in the college. The responsibility was assigned to A.O. and student representatives, as well as the supervisor. It was also decided that students would now file their complaints through the ERP System.
2. The second meeting was held on 22/09/2021 to discuss the complaint submitted by Final BDS Students regarding the hall arrangement during the MUHS Final examination. This problem was immediately resolved by the Centre In-Charge.
3. Third meeting was conducted on 30/09/2021, to discuss a complaint made by Final BDS students about disturbances caused by construction work beneath C Hall during MUHS exams. The action was taken immediately by the Centre In-Charge.
4. Fourth meeting was held on 11/02/2022, to investigate an allegation made by two interns against teaching faculty at the Department of Public Health Dentistry. The matter was thoroughly discussed, and written statements and proofs from faculty and interns were submitted to the Chairperson of the Students Grievance Redressal Committee, and a warning letter was issued to the faculty from the Dean's office.
5. Fifth meeting was held on 21/03/2022, to follow up on previous grievances and a complaint by interns about theft in the Prosthodontics department. The problem was resolved in the department, and instructions were given to the sister and interns for further necessary action.
6. Sixth meeting was held on 08/06/2022. Complaint received against fellow hostel mate for unacceptable physical abuse. Members of the Hostel Committee and the Student Grievance Redressal Committee questioned the interns involved in this matter, and an apology letter was submitted by the intern.

All academic and non-academic student grievances forwarded to the Student Grievance Committee in 2021-2022 were resolved successfully and on time. Following each meeting, a committee report is submitted to the Dean's office.
